

## TUSCARAWAS COUNTY YMCA 2025 Thomas J. Patton YMCA Scholarship



The Thomas J. Patton/YMCA Scholarship was established in 1989 by Robert (Fizz) Miller to honor Tom Patton for his 40 plus years of service to the people of Tuscarawas County through his work with the Tuscarawas County YMCA. To date, the scholarship has been awarded to 106 individuals pursuing higher education.

The scholarship is awarded each year to area students who have been active at the Tuscarawas County YMCA through participation, involvement and leadership activities. Special consideration is given to those individuals who have provided volunteer leadership.

Scholarships are awarded each year based on the following factors:

- 1. YMCA volunteer leadership
- 2. YMCA staff leadership
- 3. Financial need
- 4. Participation in church, school, and community activities
- 5. Academic ability for next level of education
- 6. Work ethic to achieve goals

All scholarship finalists will be contacted to meet with the Scholarship Committee for a personal interview, usually in April or May.
